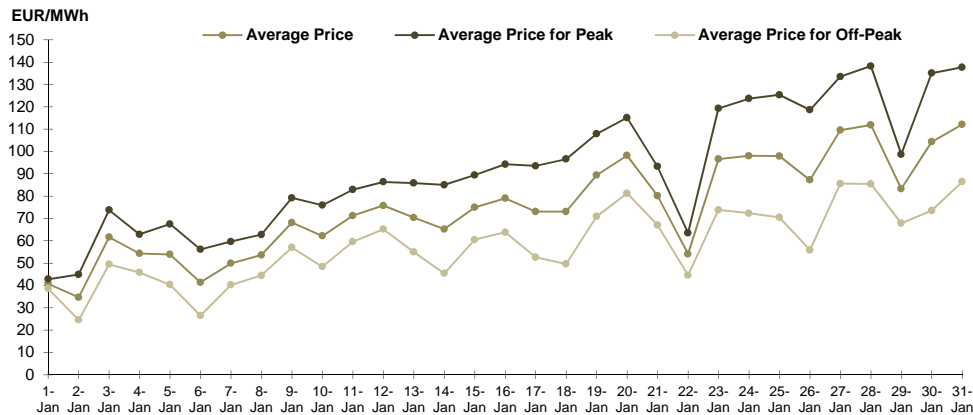


Figure 1: Daily DAM price development (base, peak and off-peak)

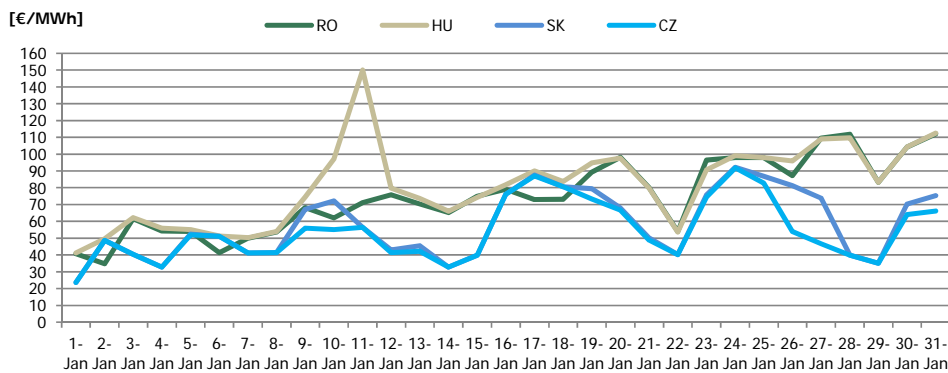


Figure 2: Daily Average DAM Price Development – 4MMC Coupling Results

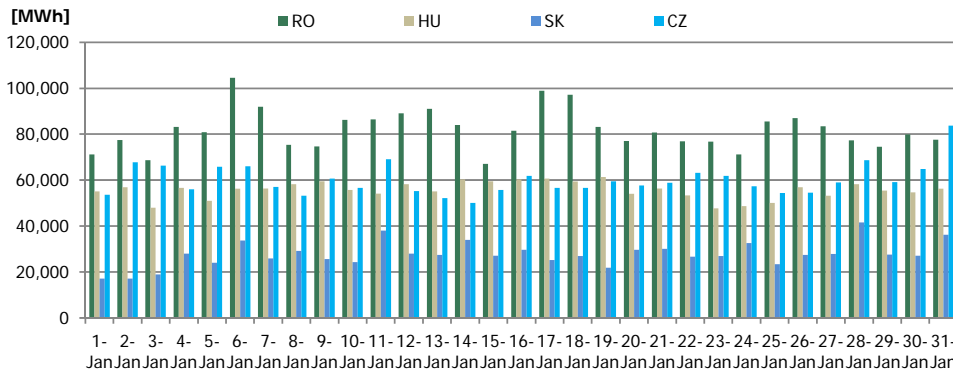


Figure 3: Daily DAM Traded Volume Development – 4MMC Coupling Results

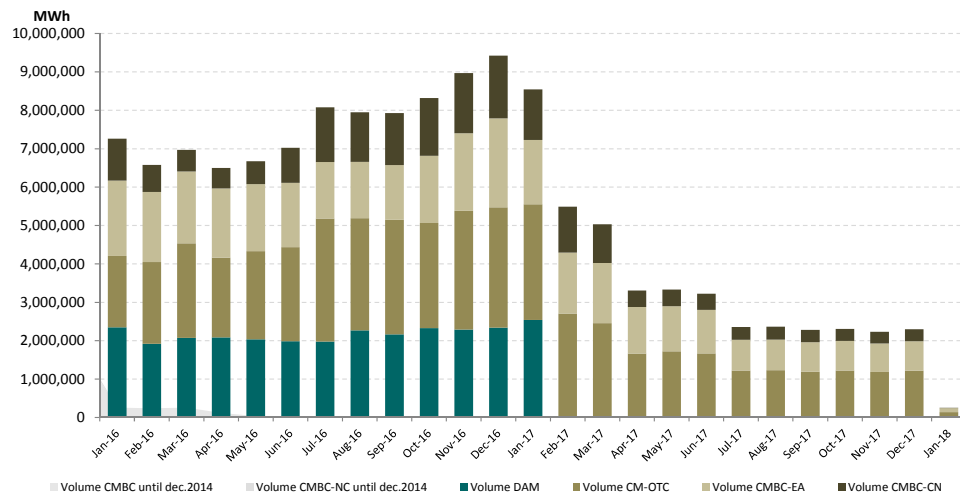


Figure 4: Monthly development for DAM transactions and deliveries according to contracts concluded on centralized market for bilateral contracts

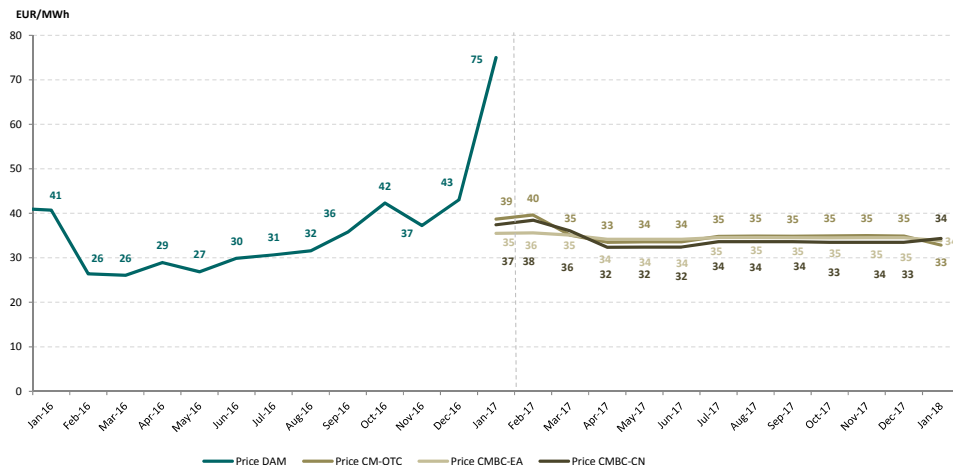


Figure 5: Monthly development for DAM average price and average price for deliveries according to concluded bilateral contracts

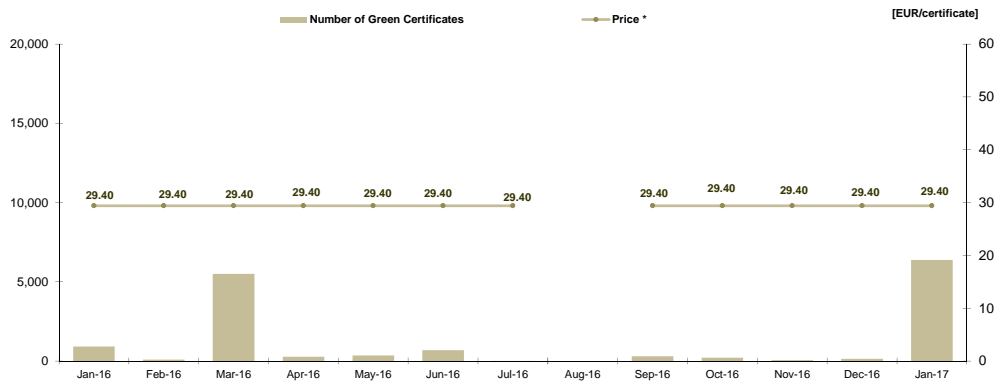


Figure 6: Monthly development for price and number of traded green certificates traded on CMGC

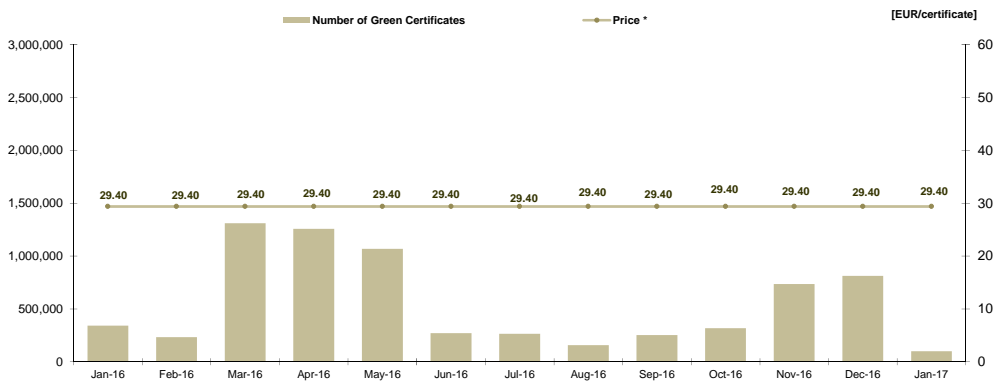


Figure 7: Monthly development for price and number of traded green certificates traded on GBCBM
