API – ID Tariff	EUR/ participant/ month	OPCOM S.A. offers the Participants access to the message interface of the M7 Trading system for the Intra-day Market ("API" - Application Programming Interface) to allow them to become API users, respectively to access the Intra-day Market trading system using programming applications. API-ID tariff is charged monthly; This tariff applies up to a limit of 120,000 events per day and/or 6,000 events per hour. An additional tariff will apply if the limit(s) are exceeded.	- 150 Euro/month - 0.03 Euro/event		OPCOM S.A. will invoice the Participant monthly for the applicable tariff and will submit the electronic invoice (to which VAT is added, as applicable) to SPV-ANAF within 5 working days from the date of issue, in accordance with the legislation in force and at least seven (7) working days prior to access granting to the API-ID. In case of the number of events is exceeded, OPCOM will issue and submit the electronic invoice for the difference (to which VAT is added, as applicable) via SPV-ANAF within 5 working days of the issuance date.	Payment of the invoice is made by participants within three (3) working days from the receipt date of the invoice in SPV-ANAF, the invoice being considered paid on the date of payment registration in the bank statement of OPCOM SA. After registration of the payment, the participant will be granted with access to the API-ID.	Access to the API-ID is subject to payment of the applicable tariffs, as published on the OPCOM S.A. website. OPCOM S.A. has the right to adjust the tariffs during the application period, subject to the publication of the new tariffs at least three (3) business days in advance. OPCOM S.A. applies the modification of the tariffs starting from the first day of the month following the month in which the modification took place; The amount paid by the participant for the calendar month of usage is not refunded if the participant's access via API-ID to the trading system is revoked, regardless of the reason (withdrawal or revocation).
