


Figure 1: Average Prices Development (base, peak and off-peak)




Figure 2: Average Price and Volume Development




Figure 3: Market Share Development




Figure 4: Electricity Deliveries according to Contracts Concluded in CMBC and average price




Figure 5: Market Share (according to Contracts Concluded in CMBC and CMBC-CN)




Figure 6: Monthly development for price and number of traded green certificates
